Description:

Eight pre-recorded modules will address ongoing and emerging issues related to the opioid epidemic and substance use disorder prevention, treatment, and recovery. These include evidence-based approaches to prevention, treatment, and recovery with a focus on special populations such as youth and adolescents, pregnant and parenting women, and people of color and/or underserved communities.

Objectives:

- Identify what works in opioid use disorder prevention, treatment, and recovery.
- Understand the components and outcomes of family-centered care.
- Outline the recommended treatment for women, including pregnant women.
- Learn why adolescents are especially vulnerable to opioid misuse and opioid use disorders
- Recognize the risk and protective factors contributing to adolescent substance use
- Describe substance use disorder using person first language
- List two terms/word that can replace stigmatizing terms/words often used when discussing substance use disorder
- Outline the impact of stigma on substance use disorder treatment and recovery
