This virtual coffee break was created by the Clinical Training Center for Sexual Reproductive Health. It is intended for Title X program clinical providers, pharmacists, nurses, and other staff who provide contraception counseling and administration. This brief learning opportunity will prepare participants to confidently discuss the types of intrauterine contraception (IUC) and their mechanisms of action, identify criteria for patient use, and describe the efficacy and duration of use for each.

Objectives:

- Define the methods of intrauterine contraception (IUC)
- Discuss the mechanisms of action for each type of IUC
- Describe the nomenclature for intrauterine devices, including brand names
- Identify FDA-approved duration of use for each type of IUC
- List the criteria for candidate selection
