

## Safety Planning for Youth Suicide Prevention On-line Course

## Overview

In this course, participants will develop their knowledge and skills in using the Stanley-Brown Safety Planning Intervention, an evidence-based collaborative intervention for clinicians and clients at risk of suicide. Participants will learn the core elements of the Safety Planning Intervention, strategies for collaborating with young clients and their family members, and ways to overcome challenges.

- Gain skills for collaborating with family members in the safety planning process
- Determine next steps for implementing the safety plan and following up with the client
